BOARDING CONTRACT

This is a Contract between Dog Day Afternoon, LLC and the pet owner whose signature appears below (hereinafter called "Owner").

1. Dog Day Afternoon, LLC agrees to exercise reasonable care for the pet delivered by the Owner to Kennel for boarding, and to keep its premises sanitary and properly enclosed. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the Dog Day Afternoon, LLC.
2. Dog Day Afternoon, LLC does not assume and shall not be held responsible for any liability with respect to the pet listed in this agreement, of any kind whatsoever, arising out of or from the boarding of this pet, or any damages which may accrue from any other cause whatsoever, including loss by fire, theft, disease, running away, death, injury to persons, animals, or property, or death or injury to any other animal caused by the within named pet during the term of this contract.
4. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time said pet is in the care of the Dog Day Afternoon, LLC.
5. Owner has provided proof of vaccinations of the pet and has provided information that they are the sole owner of the pet.
6. If pet(s) becomes ill or if the state of the animal's health otherwise requires professional attention, Dog Day Afternoon, LLC, in its sole discretion, may engage the services of a Veterinarian on staff or administer medicine or give other attention to the animal, and the expenses shall be paid by the Owner.
7. All charges incurred by Owner shall be payable upon pick-up of pet, or when billed by Dog Day Afternoon, LLC at address listed on contract. The Dog Day Afternoon, LLC shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding pet at the kennel. Owner further agrees that the pet shall not leave the kennel until all charges are paid to Dog Day Afternoon, LLC by Owner. A late fee will be charged plus additional boarding charges until payment is received. The Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, Dog Day Afternoon, LLC may exercise its lien rights upon ten days written notice given by Dog Day Afternoon, LLC to Owner by certified mail to address shown on contract. Dog Day Afternoon, LLC may dispose of pet for any and all unpaid charges, at private or public sale, in the sole discretion of the Dog Day Afternoon, LLC, and Owner specifically waives all statutory or legal rights to the contrary.
8. By signing this contract, the Owner is also stating that their pet is on flea preventative and if the pet does come into Dog Day Afternoon, LLC with any fleas, the pet will be immediately administered a medication for removal of fleas or given a flea dip bath at a cost to the Owner. The prevention of fleas is to protect the other pets boarding here and the employees.
9. Owner MUST pick up the pet by 12:00 pm on the scheduled day of pick up or Owner will be charged for an additional night of boarding.
